ORGANIZATION AGREES TO PAY WDT **\$75.00**. EACH WORKER IN THE  
BOOTH MUST PAY A **\$35.00** REGISTRATION FEE, UNLESS THEY ALREADY  
HAVE PURCHASED A COMBO TICKET. Plus **\$94.00** FOR HEALTH DEPT  
PERMIT.

I. IT IS AGREED THAT WORLD DEAF TIMBERFEST WOULD PROVIDE THE  
ORGANIZATION THE FOLLOWING:

A. A FIRE EXTINGUISHER. A DEPOSIT OF \$ 25.00 SHALL BE REQUIRED  
WHICH WILL BE REFUNDED. (or bring your own and save the \$25.00 deposit)

B. STORAGE SPACE IN THE WALK-IN COLD STORAGE IN THE KITCHEN OF  
THEPAVILION.

II. IT IS FURTHER AGREED THAT THIS ORGANIZATION SHALL:

A. NOT SELL ANY BEVERAGES OTHER THAN TEA, SPORTS DRINKS,  
LEMONAIDE, MILK, OR COFFEE. ALL OTHER BEVERAGES SHALL BE SOLD  
BY WDT UNLESS SPECIFIED IN THE CONTRACT.

B. NOT SELL ANY FOOD THAN WHAT IS LISTED ON THIS CONTRACT.

C. PROVIDE THEIR OWN COOKSTOVE, COOKING PANS, UTENSILS AND

COOLERS. NOTHING MAY BE TAKEN FROM THE KITCHEN IN THE PAVILION WHICH IS THE PROPERTY OF CAMP TALOALI, INC.

D. AT LEAST HAVE ONE WORKER IN THE BOOTH THAT HAS AN OREGON FOOD HANDLERS PERMIT AT ALL TIMES. MAKE A COPY TO SEND WITH THIS APPLICATION.

III. IT IS FURTHER AGREED THAT THIS ORGANIZATION AND ITS MEMBERS SHALL ABIDE BY ALL THE RULES AND REGULATIONS AS SET FORTH IN THE WDT BROCHURE AND THE WAIVER.

IV. IT IS FURTHER AGREED THAT CAMP TALOALI, INC. AND WORLD DEAF TIMBERFEST, INC. SHALL NOT BE HELD LIABLE FOR ANY THEFT, DAMAGE, OR LOSS OF ANY ARTICLES OF THE ORGANIZATION. **NOTE:** WE SUGGEST THAT ORGANIZATION DO NOT LEAVE ANYTHING IN THEIR BOOTHS DURING CLOSING HOURS.

V. IT IS FURTHER AGREED THAT WDT RESERVES THE RIGHT TO CANCEL OR TERMINATE THIS AGREEMENT AND/OR THAT THE ORGANIZATION'S SERVICE BE DISCONTINUED FOR BREACH OF CONTRACT OR FOR ANY JUSTIFIABLE CAUSE. NO REFUND SHALL BE AWARDED.
